ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS

SUMMARY

Offer Price and Net Proceeds from the Share Offer

- The Offer Price has been determined at HK\$0.32 per Offer Share (excluding brokerage of 1.0%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$0.32 per Offer Share, the net proceeds from the Share Offer to be received by the Company, after deducting the underwriting commission and related expenses in connection with the Share Offer, is estimated to be approximately HK\$56.0 million. The Company intends to apply such net proceeds in accordance with the purpose set out in the paragraph headed “Business Objectives and Future Plans – Implementation Plans” in the Prospectus and the paragraph headed “Net Proceeds from the Share Offer” below in this announcement.

The Public Offer

- The Public Offer Shares initially offered under the Public Offer have been significantly over-subscribed. A total of 3,623 valid applications have been received pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms and by giving **electronic application instructions** to HKSCC via CCASS for a total of 407,910,000 Public Offer Shares, representing approximately 16.32 times of the total number of 25,000,000 Public Offer Shares initially available for subscription under the Public Offer.
- Due to the over-subscription in the Public Offer, the reallocation procedures as described in the paragraph headed “Structure and Conditions of the Share Offer – The Public Offer – Reallocation” in the Prospectus have been applied. As the number of Offer Shares validly applied for in the Public Offer represents more than 15 times but less than 50 times of the number of Offer Shares initially available under the Public Offer, 50,000,000 Offer Shares have been reallocated to the Public Offer from the Placing, so that the total number of Offer Shares allocated to the Public Offer has been increased to 75,000,000 Offer Shares, representing 30% of the total number of Offer Shares initially available under the Share Offer.

The Placing

- The Placing Shares initially offered under the Placing have been moderately over-subscribed. The final number of Placing Shares allocated to 244 placees under the Placing is 175,000,000 Placing Shares after reallocation to the Public Offer, representing 70% of the total number of Offer Shares initially available under the Share Offer. A total of 117 placees, representing approximately 48.0% of the total number of placees under the Placing, have been allotted five board lots of Shares or below. These placees have been allotted approximately 2.3% of the 175,000,000 Offer Shares (after reallocation) available under the Placing.

Offer Size Adjustment Option

In connection with the Share Offer, the Company has granted to the Placing Underwriters, exercisable by the Sole Lead Manager (on behalf of the Placing Underwriters) the Offer Size Adjustment Option. Pursuant to the Offer Size Adjustment Option, the Company may be required to allot and issue up to an aggregate of 37,500,000 additional Shares, representing 15% of the Offer Shares initially being offered under the Share Offer. The Offer Size Adjustment Option can only be exercised by the Sole Lead Manager at any time before 6:00 p.m. on the Business Day immediately before the date of this announcement. The Sole Lead Manager has not exercised the Offer Size Adjustment Option by the aforesaid time and the Offer Size Adjustment Option has accordingly lapsed.

NET PROCEEDS FROM THE SHARE OFFER

Based on the Offer Price of HK\$0.32 per Offer Share, the net proceeds from the Share Offer to be received by the Company, after deduction of the underwriting commission and related expenses in connection with the Share Offer, is estimated to be approximately HK\$56.0 million.

One application has been rejected due to bounced cheques. No multiple application or suspected multiple application has been identified. No application has been rejected due to invalid application. No application for more than 25,000,000 Public Offer Shares initially available under the Public Offer Shares, representing 100% of the Public Offer Shares initially comprised in the Public Offer, has been identified.
